In exercise of the powers under Section 3 of the Uttar Pradesh Urban Planning and Development Act, 1973 (President's Act No. 11 of 1973), as re-enacted and modified by the Uttar Pradesh President's Acts (Re-enactment with Modifications) Act, 1974 (U.P. Act No. 30 of 1974), read with Section 21 of the U.P. General Clauses Act, 1904 (U.P. Act No. 1 of 1904), the Governor is pleased to rescind the Government Notification No. 3065/XXXVII-2-28-DA-75, dated April 29, 1978 published in the U.P. Gazette Extraordinary, dated April 29, 1978 pertaining to determination of limits of Agra Development Authority Area notified under Government Notification No. 3923/XXXVII-2-4(DA)-74, dated September 11, 1974 and published in the U. P. Gazette Extraordinary, dated September 11, 1974 and to determine the development area of the Agra Development Authority as hereunder.

In the aforesaid Notification No. 3923/XXXVII-2-4-DA-72, dated September 11, 1974, for the existing Agra Development Area, the following shall be substituted, namely :—

Agra Development Area

Area falling within the limits of the Nagar Mahapalika Agra and the 163 revenue villages mentioned in the Schedule below but excluding Cantonment areas, Dayal Bagh Town Area and lands owned, requisitioned or taken on lease by the Central Government for the purpose of any naval, military or air force authority.

Aligarh Development Area¹

Area included in Aligarh regulated area notified under sub-section (1) of Section 3 of the U.P. (Regulation of Building Operations) Act, 1958 (U. P. Act No. XXXIV of 1958), and the areas falling within the radius of 3. Km. of Aligarh Municipal limits excluding land owned requisitioned or taken on lease by Central Government for the purpose of any Naval, Military or Air Force Authority.

The Aligarh Development Authority (Fee for Inspection or Obtaining Copies of Documents and Maps) Regulations, 1983²

The following regulations regarding the fee to be paid for inspection or obtaining copies of documents and maps of the Authority are made in exercise of the powers under clause (6) of sub-section (2) of Section 56 of the Uttar Pradesh Urban Planning and Development Act, 1973 (President's Act No. 11 of 1973) as re-enacted with modifications by the Uttar Pradesh President's Acts (Re-enactment with Modifications) Act, 1974 (U. P. Act No. 30 of 1974) by the Aligarh Development Authority, after previous approval of the State Government, under sub-section (1) of Section 56 of the aforesaid Act.

1. Short title and commencement.—(1) These Regulations may be called the Aligarh Development Authority (Fee for Inspection or Obtaining Copies of Documents and Maps) Regulations, 1983.

(2) They shall come into force with effect from the date of their publication in the Gazette.

(3) They shall be applicable to the Aligarh Development Area.

2. Application.—If a person wishes to inspect any record or document or to obtain any copy of any record or document, or extract therefrom belonging to or in the possession of the Development Authority, he shall apply in writing to the Secretary and where any other person is named or
